8.2 Exposure controls 8.2.1 Appropriate engineering controls

8.2.2 Individual protection measures, such as personal protective equipment

General hygiene measures for the handling of chemicals are applicable.

Remove contaminated clothing and protective equipment before entering areas in which food is consumed.

Eye/face protection: Tight fitting protective goggles (EN 166) with side protection, with danger of splashes.

Skin protection - Hand protection: Protective nitrile gloves (EN 374). Permeation time (penetration time) in minutes: > 480 Minimum layer thickness in mm: 0,4 Protective hand cream recommended.

The breakthrough times determined in accordance with EN 16523-1 were not obtained under practical conditions. The recommended maximum wearing time is 50% of breakthrough time.
